Litigation Risk Assessment Michaela Keet, 2018 Without clear projections about where the path of litigation is most likely to lead, clients can be anchored in unrealistic expectations about the outcome and the costs of getting there. Fundamental to the lawyer's ethical role is the obligation to provide transparent information about legal rights and risks and fundamental to settlement processes is the presumption of informed decision making.
