#### I. Authority

- Mutual Rearing of Children: Both parties will share in the upbringing of any children, providing them with a nurturing and loving environment.
- Mutual Support:
  - Financial: The Husband shall primarily work outside the home, provided he is able. As the primary
    income provider, the Husband will rely on the Wife to primarily manage childcare, housekeeping,
    cooking, and cleaning.
  - Life Insurance: Life insurance shall be maintained until the parties have accumulated sufficient wealth to provide for the survivor for at least [NUMBER] years.
  - Moral: Both parties shall support each other morally, by example and exhortation.

#### IV. The Prohibitions

The following actions or behaviors shall constitute violations of this marriage contract:

- 1. Adultery: Any sexual activity or conduct with a person not party to this agreement.
- Abandonment: Filing for legal separation or divorce, or deserting the marital home for at least six months, regardless of financial support.
- 3. Abortion: The deliberate termination of a pregnancy or the use of abortifacient birth control methods.
