sovereignty while accommodating forced migrants. Whittaker's more objective view of these issues is his book's greatest strength and weakness. No book about such a controversial topic can be completely objective and he, like Marfleet, advocates more for forced migrants themselves rather than for nation-state interests. Further, in Whittaker's book of 144 pages, his arguments are often summarized in bullet points providing superficial detail. This approach does not give the reader a comprehensive introduction to the subject. Marfleet's book is more rigorously argued and his ideas are more consistent throughout. His novel approach in describing the history of migration is useful and fascinating even for those well acquainted with contemporary forced migration issues. Unfortunately, his open borders hypothesis is likely to alienate some readers who argue for the fundamental protection of the nation-state in the age of terror. Whittaker's and Marfleet's books are timely and simultaneously answer questions and raise many more about the future of the refugee regime.
