Brief Background/Introduction

- RA No. 11057 or Personal Property Security Act ("PPSA") was enacted on August 17, 2018, to strengthen
 the secured transactions legal framework in the Philippines, and provide for the creation, perfection,
 determination of priority, establishment of a centralized notice registry, and enforcement of security
 interests in personal property (tangible and intangible), except aircraft and ships.
- Although this law took effect on September 7, 2018, 15 days after the publication in two newspapers of
 general circulation, its full implementation is conditioned upon the Registry being established and
 operational. However, the registry has not yet been established as of this writing but the implementing
 rules and regulations of the PPSA ("PPSA Rules") were published last flovember 18, 2019 and have become
 effective on December 3, 2019. Nevertheless, the PPSA Rules directed the Land Registration Authority to
 establish the registry within six months from the publication of the PPSA Rules.

RA No. 11057 Personal Property Security Act

State Policy

It is the policy of the State to promote economic activity by increasing access to least cost credit, particularly for micro, small, and medium enterprises (MSMEs), by establishing a unified and modern legal framework for securing obligations with personal property. (Sec. 2, PPSA)
