Posttraumatic Stress Disorder (PTSD) is a disorder that has captivated the attention of the legal profession in the area of psychological injury, in some part perhaps by providing for plaintiffs a more tangible way of expressing "pain and suffering" inflicted by injury. This view assumes that the research regarding etiology, phenomenology, prevalence, course, comorbidity, and biologic underpinnings has fully resolved all outstanding issues. Yet, the nature and description of PTSD is still in the process of being more carefully studied. In this review, we highlight some of the current issues that researchers are studying and suggest which ones necessitate caution in the legal arena.

PTSD as a Multicausal System

The Diagnostic and Statistical Manual of Mental Disorders (DSM-IV and DSM-IV-TR) (American Psychiatric Association, 1994, 2000) specifies the diagnostic criteria for PTSD. The diagnosis has undergone several revisions over the years, mostly in relation to defining trauma exposure rather than describing phenomenology of this disorder. When first introduced in the DSM-III in 1980, individual differences in PTSD were minimized (American Psychiatric Association, 1980; Miller, 2003) because the underlying assumption behind the diagnosis was that traumatic stress constituted the most important, if not sole, etiologic agent or cause of PTSD (Yehuda & McFarlane, 1995). The traumatic events considered necessary to elicit PTSD were defined as "outside the range of usual human experience" (American Psychiatric Association, 1980, p. 238) and, therefore, would evoke "significant symptoms of distress" in most victims of the events. Implicitly, PTSD was conceived as a normal response to extraordinary traumatic events (Yehuda & McFarlane, 1995).

Yehuda et al. (2005) pointed out that the current fourth version of the DSM represents a paradigm shift with regard to the issue of the "Criterion A" stressor, because it placed emphasis on the variability in individuals'
