

THE LAW

8 Rights of a citizen accused of a crime:

1. **Protection from Double Jeopardy** (person can only be re-tried in case of a hung jury)
2. **Right to a grand jury** (5th) – decide if evidence warrants a trial; 16-23 people; Issue an **indictment** (formal charges)
3. **Protection of Self-Incrimination** (taking the 5th) – if you refuse to testify about another person involved in a crime who are held in **contempt of court**.
4. **Right to Speedy and Public Trial** – (6th) – federal cases must take place within 70 days of charges
5. **Right to Appeal a Verdict** – errors made, lack of evidence, new evidence, etc.
