state owned enterprises Because each country has different circumstances it is impossible to provide a unique model for privatisation each country needs to design its own model according to its circumstances Privatisation is an essential but insufficient element for structural economic reform in the economy and society Privatisation is not a panacea it is not the solution to every economic and administrative problem selling an enterprise to the private sector does not mean an end to all problems Also privatisation is not an overnight process or a magic touch it will be a lengthy process Furthermore a decision that something can be privatised does not mean that it should be privatised In that context privatisation is not good or bad it is an economic and social instrument If it is well designed it may bring substantial benefits to the economy and society In many countries many state owned enterprises particularly the ones which are financially weak have still not been privatised. This finding revealed that the privatisation process will be in the political and economic agenda for at least few more decades
